Petaluma Architect Selected

The Bluerock Partnership (tBP) was selected as the Science Laboratory and Student Services project architect at SRJC Petaluma. tBP was recommended by the selection committee in a competitive process. The team will work closely with SRJC Faculty, Staff and RFD, the Science, Technology, Engineering and Math (STEM) lab planner.

SRJC Petaluma held a project kick off meeting on April 13th led by the tBP and RHAA (the landscape architect). The interactive planning session was well attended. Kudos to Board President Maggie Fishman for making time to attend and special thanks to Dr. Jane Saldaña-Talley, Dr. Catherine Williams, Dr. Matthew Long, Maria Banachowicz and Roxanne Epstein for organizing the event.

KAD Project Kick-Off



The Kinesiology, Athletics and Dance (KAD) Faculty, Staff and Dean met with the Gensler planning team to kick off the programming phase of their project on March 31st.

The day started with a tour of the facility, followed by meetings with individual team coaches and a team workshop. Faculty and staff expressed their specific requests related to:

- Tauzer Gym upgrades
- Athletic field improvements

- Bailey football, track and field improvements
- Swimming pool
- Soccer, softball and baseball field upgrades

The meetings were well attended and the second set of meetings will be held on April 27th and 28th.

Analy Village Swing Space

Work has started on the Analy Swing Space project. The project will house the Communications Department during the modernization of Burbank. Two buildings will be placed in the parking lot north of the Copy Center. Work is slated for mid-May, 2017 and an announcement was sent to DL Staff.All.

STEM Lab Planner

A second set of STEM lab planning workshops were held on April 13th and 14th for STEM faculty and staff. The goal is to develop specific lab programs. Once the project is funded by the State, a project architect will be hired to design the overall building, utilizing the documentation being prepared by the lab planner.

Burbank Auditorium Modernization Project

The project design phase is complete and was submitted to the Department of the State Architect (DSA) for review. In the meantime, swing space work continues as two departments - Theatre Arts and Communications – prepare to move to their temporary facilities.

In addition to the swing space created for Communications

(see separate story), Theater spaces will be housed across from Lark Hall, adjacent to the baseball field. This project is projected for summer 2017 and the Theatre Arts department will begin their Fall 2017 program in these buildings. The Summer Repertory Theatre (SRT) will perform in the old Burbank Theater the last time in 2017, and return in summer 2019 when the project is complete.



Citizen's Bond Oversight Committee

The quarterly meeting of the Citizens' Bond Oversight Committee (CBOC) was held on April 10, 2017 in The Rotary Center for Student Leadership. The role of the committee is to insure that Measure H funds are spent according to the bond ballot language, and to communicate bond activities to the public. The committee reviewed a draft version of their Annual Report which will be presented to the Board of Trustees in May. The meeting is open to the public and the agenda is posted electronically and at the SRJC posting sites.

Sustainability Projects

A Photovoltaic installation contractor will be recommended to the Board in May. Other projects continue forward, including:

- Quinn water reclamation
- Energy metering and monitoring systems
- PV system at Shone Farm
